RULES

HOMES OF HOPE: Crawford Hoying will provide five (5) families rent-free apartment housing for one (1) year. The families chosen will be selected by The Salvation Army, which helps hundreds of Central Ohio residents find much needed housing every year. Nominations will be accepted from Wednesday, June 16, through 5:00 pm on Friday July 16, 2010.

HOW TO NOMINATE A FAMILY: Nominate online at www.sunny95.com. Hard copy nomination forms are available at the Columbus Radio Group offices at 4401 Carriage Hill Lane, Columbus, Ohio 43220, any Crawford Hoying community and on the Crawford Hoying website at www.crawfordhoying.com.

ELIGIBILITY: To be eligible to receive one (1) of five (5) rent-free homes through Homes of Hope, the head of household must be 18 years of age or older. Employees of Crawford Hoying, Sunny95, Kroger, Bins, Time Warner Cable, The Salvation Army, their advertising and promotion agencies, affiliates, subsidiaries, and any individual or company directly associated with this community outreach program, their immediate families (parents, children, siblings, spouse), and members of their respective households (whether related or not) are ineligible to receive Homes of Hope rent-free apartment housing.

CONDITIONS: Five (5) families will receive rent-free apartment housing for one (1) year at a location chosen by Crawford Hoying. This housing includes rent only, and does not include any other amenities, including utilities. No transfer, substitution or cash value equivalent is available. Each selected family will need to pass a credit and criminal screening, sign a lease and agree to comply with the rules and regulations of the respective housing community, take occupancy within forty-five (45) days after being notified, and pay any applicable taxes. The family selections made by The Salvation Army and the housing community selections made by Crawford Hoying are final. The Salvation Army review team will select five (5) nominees with selection focused mainly on need.

ANNOUNCEMENT OF SELECTED FAMILIES: Each weekday from Monday, July 26, 2010, through Friday, July 30, 2010, one family will be announced on the Sunny95 morning radio show by hosts Dino and Shawn. The promotions team from Sunny95 will also make contact with the selected families by phone.

ACCEPTANCE: By accepting the apartment housing, the family will assume all liability for any injury or damage caused or claimed to be caused by participating in this program. The sponsors retain the right to amend, modify or terminate this program at any time.
